Deposits

Deposits are required at the time you make your reservation:

1 day trips: 50% per person

Overnight trips: \$100 per person

the balance is due one week prior to the day of the trip. For Group Rates, one person needs to collect for the group and make payment.

Cancellations

Deposits, minus a \$25 handling fee, are refundable provided Imperial River Company is notified at least 2 weeks prior to trip departure. If cancellation is given less than 2 weeks prior, we reserve the right to reschedule your trip or retain the deposit.

Children

Children 12 and under must be accompanied by a parent, grandparent or guardian. They must be over 6 years old, and weight at least 50 lbs.

Pets

For your pet's safety and happiness, please make arrangements to leave them at home or with someone that can provide for their welfare. We do not have the facilities to safely accommodate pets.

Alcohol

We do not allow alcohol to be consumed while on the water during any of our trips.
